There are two things you need: life and career experiences. Couple these ingredients with the insight of a few people who have seen you in action over the years, can honestly tell you what your commodity or USP is and can give you a firm shove to 'just get out there'!

The best advice I was given when I took the leap of my supporters' faith (I don't think I believed it myself for a long time) was from a fellow jumper a few months ahead of me: "Whatever you are doing now won't be what you are doing in a year's time — but everything you explore will direct you to that place". She was quite right. Her next piece of advice — given a year later — was different: "Carefully review everything you are offered and only agree to it if it's in line with your brand". This definitely isn't about 'following the money' but about being true to yourself.

When the Side Hustle you love becomes your main occupation you MUST ensure it remains lovable and we all know how easy it is to be distracted by the more obvious commercial goals. So, stay focused on what you really care about and delight in the world you have embraced. Be proud to be an official member of the 'Side Hustle Economy'!
